By signing this contract, purchaser agrees to pay total cost of event three weeks prior date of said event. The client agrees to provide a table for Donatelli Entertainment (minimum 6 ft long) If no table is provided, client will assume the charge of \$50 to have one provided by Donatelli Entertainment. The client agrees to provide adequate shelter for the performer and equipment for ALL outdoor events (tent or pavilion). Performer has the right to cancel without refund if adequate shelter is not provided for the event. In this case Donatelli Entertainment will have the final determination if the shelter is adequate. Donatelli Entertainment requires access to the performance location at least two hours prior to the event start time. The client assumes responsibility for any damage to Donatelli Entertainment's equipment caused by you or your guests. It is the client's responsibility to clear time and space with the venue management. No refunds will be given if there is any delay in start time. If this agreement is cancelled prior to 60 days before the event date, the purchaser will receive all funds given to Donatelli Entertainment, except the 25% deposit. If this agreement is cancelled within the 60 day period prior to the event, no refund will be given. It is the client's responsibility to make sure that Donatelli Entertainment is provided with adequate electrical outlets, supplied with at least 15 amps, within 30 feet of the performance area. This circuit must be free from any other connection plugged into it to disrupt signal and amps. In the event that any of the above conditions are not met, Donatelli Entertainment has the right to cancel at any time, with no refund. These conditions have been explained and agreed upon by both parties that have signed this document and who will abide by conditions set forth above.
